



# INNOVATION FUND 2022 – LATIN AMERICA AND THE CARIBBEAN TERMS AND CONDITIONS

The **Innovation for Change (I4C) Hub**'s mission is to empower civil society to defend civic space. With the support of Tides Center, I4C is launching the Innovation Fund for Civil Society Organizations in Latin America and the Caribbean that work to strengthen the sector through innovation.

As part of I4C, the Argentine Network for International Cooperation - RACI - opens this new call for proposals to support 3 (three) local, national, and regional organizations in Latin America and the Caribbean, with financial resources - up to USD 10,000 each - to address challenges related to one of the following areas:

## **Promotion of the Enabling Space**

Activities dedicated to strengthening and improving the conditions in which Civil Society and its organizations operate.

## **Democracy and Citizen Participation**

Activities that refer to the strengthening of democratic mechanisms and institutions and/or the involvement of citizens in decision-making processes.

## **Diversity and Inclusion**

Actions that promote spaces where differences are recognized as opportunities to generate processes with a view to leaving no one behind, whether at the political, economic, or social level.

# **Transparency and Accountability**

Activities related to "openness regarding decisions and activities that affect society, the economy and the environment, and willingness to communicate them in a clear, accurate, timely, honest and complete manner", assuming responsibility for what has been done.

#### The I4C Hub has the following goals:

- Strengthening and empowering CSOs in the LAC region to protect civic space through innovative seed-funding initiatives and movements that creatively address community challenges related to: (i) promotion an enabling environment; (ii) democracy and citizen participation; diversity and inclusion or (iii) transparency and (iv) accountability .
- Generating innovative, practical tools that positively impact community challenges related to the above topics and which can be shared and made available for replication in I4C LAC and the I4C network.

#### Who can apply?

Only non-profit Civil Society Organizations from Latin America and the Caribbean may apply to become beneficiaries of the Innovation Fund. The Program will not accept proposals from individuals, companies, or governments. Organizations must be legally registered and have a bank account in their name that can accept transfers in U.S. dollars.

What is the timeframe to complete the project, and how much funding is provided?





Projects may last up to 4 months. The Fund will provide up to a maximum of USD 10,000 (ten thousand US dollars) per project. Only one proposal per CSO will be accepted.

The selected CSOs must submit a mid-term progress report and a final report at the end of the project. The provision of funds will be subject to the approval of these reports.

#### Which activities are not eligible?

- International travel/participation in foreign conferences and lodging.
- Political, religious, or evangelical activities. Religious associations will not be excluded as long as the proposed project meets the objectives of the Fund, does not exclude followers of other religions, and the funds are not used to support proselytizing activities.
- Ongoing or recurring funding of the beneficiary organization's operating/operational expenses, such as salaries and wages, office supplies, and communications that are not relevant to the project submitted.

## **Application Process**

RACI will coordinate the application process. It consists of two phases:

### Phase 1 - Expression de Interest (EOI)

Interested organizations will submit a concept note (Form 01 – Concept Note), following the steps below:

- 1- Download the document "Form. 01 Concept Note Innovation Fund 2022" by clicking here.
- 2- Complete the downloaded document, clearly and not exceeding the space allocated for each category/question.
- 3- Attach the "Form. 01 Concept Note Innovation Fund 2022" document in the following Google Forms and complete the Form with the required information.

We have extended the deadline! The deadline for submitting concept notes will be Sunday June 26, 6:00 PM, Argentina Standard Time (GMT-3). Projects received after the deadline will not be considered.

Following reception of applications, RACI will select those projects that meet the criteria and requirements of the fund. Those organizations shortlisted in this phase will be notified by email, and will be invited to participate in the second phase where they will have to submit an Expanded Application Form.

## <u>Phase 2 – Expanded Application Form</u>

Shortlisted organizations will receive an email inviting them to complete and submit Form 02 - Expanded Application, following the steps below:

- 1. Download "Form 02 Expanded Application Form Innovation Fund 2022".
- 2. Complete the Application Form, in English or Spanish and attach any additional information, quotes, or purchase orders etc, if necessary.





3. Sign the application form. This should be done by one of the Organization's Directors. The form should be sent as a Word or PDF (editable) to: <a href="mailto:fondoinnovacionalc@raci.org.ar">fondoinnovacionalc@raci.org.ar</a>

The deadline for submitting the Expanded Application Form will be Thursday, July 14, 6:00 PM (Argentina time).

## **Selection Criteria**

#### 1. Organization Profile - 10%

Background and capacity of the organization in terms of the activity and theme presented in the project. The possibility of generating alliances and collaboration with other actors will also be considered.

## 2. Project feasibility - 20%

The proposal should be achievable within the set timeframe, with Specific, Measurable, Achievable, Realistic and Time-bound (SMART) goals.

### 3. Project analysis - 25%

The analysis will take into account whether the project fits the Fund's objectives, the clarity of the proposal, the proposed activities contribution to the stated objectives, and that the project meets a concrete and well-defined need and is relevant to the target audience and the local context.

## 4. Budget - 20%

The project budget should be cost-effective and clearly detailed and in compliance with eligible expenses.

# 5. Innovation and Sustainability - 25%

The extent to which the project proposes a novel and better (more efficient, effective, of higher quality) solution (process, product, service) to a social problem than traditional approaches will be taken into account. On the other hand, it is expected that the project's objectives and positive impact will last beyond the project's completion date.





# **SCHEDULE**

#### 1st. Stage - Concept Notes Receipt - tentatively June 2022

The call for concept notes will be open from Wednesday, June 15 through Sunday, June 26, 6:00 PM, Argentina Standard Time (GMT-3).

### 1st. Selection – tentativelyJune 2022

The RACI team will review the concept notes received, taking into account the five dimensions mentioned in the call for proposals under the "selection criteria" section.

### 2nd. Stage - Expanded Application Forms - tentatively July 2022

The receipt of Extended Application Forms from those organizations shortlisted will be open from Friday, July 1 until Thursday, July 14, 6:00 PM, Argentina Standard Time (GMT-3).

## 2nd. Selection - tentatively July 2022

RACI's team, together with the I4C Regional Executive Committee, will assess submitted proposals based on the same criteria.

## 3rd. Stage - Contact with Selected Organizations - tentatively July / August 2022

RACI's team will contact selected organizations to start administrative proceedings.

# Announcement of Selected Projects – tentatively August 2022

Selected projects will be announced on RACI's website and I4C LAC HUB social media.

Please note that these are estimated dates which may change for reasons beyond RACI's control. Selected organizations may be required to postpone the start date of projects while the end date will have to remain the same.
